

C.E.S. Coordinated Entry System is a localized system of efficiently routing households who are homeless or at risk of homelessness to the most appropriate provider among the network of homeless service providers, as quickly as possible.



Required Documents for Screening:

Picture ID for all adults in the household (18 and over).

Social Security Cards for all household

members or official letter from the Social Security Administration documenting that a card has been requested and noting the number.

Official identification for all children in the household: birth certificate, medical

coup on, school enroll ment, etc.

Homeless Status Verification: Referral letter from shelter/service provider; eviction notice; landlord letter; Notice to terminate tenancy signed from family or friends that they can no longer remain in the current housing.

Proof of Crisis which caused the evic-

Gion: Police report, medical bills showing payment, increase utility bill showing payment, loss of job/unemployment claim, etc.

Copy of Lease/Rental Agreement: Copy of Lease/Rental Agreement listing you/ applicant as the renter of the unit.

Verification of Income for ALL adults in the household: (three prior months and current month that you are applying)
